Subject: Current Finances

As we will not have the benefit of the interest on our CD in the amount of \$63,650. until 17th July, 1991, Chairman DeMay has asked me to send you a statement of the current cash requirements from now until July 17th.

Attorney Mayer has been paid \$3000 of the \$3400 due on this account.

Ms. Benedict has advised me that she failed to bill the Perimeter Committee for an invoice paid by the Village to Attorney Mayer in December 1990 for \$480.

The insurance now in force on the Compact's property for general hazzard and liability has a premium due of \$1066. This was authorized at our organizational meeting held on 15th May.

Chairman DeMay has advised me that Beaumont and Stork has quoted an annual premium of \$3692 for Public Officials Liability insurance to protect the commissioners and employees of the Village working on Compact matters. This policy has a million dollar coverage with a \$10,000 deductible. We may need to meet to further review this coverage.
